You will need a CAS (Confirmation of Acceptance for Studies) to support your Student Route visa application.

Once you have met the conditions of your offer, have paid a deposit, and have the required supporting documents, please complete and return this CAS Request form to cas@aub.ac.uk. Provided all the required information has been included and you pass AUB's immigration check, your CAS will be issued and emailed to you within 5 working days.

Your CAS will only be issued if you hold an unconditional offer. We can also issue your CAS if the only condition remaining on your offer is English language and you will be studying an AUB Pre-Sessional course on campus.

FEE INFORMATION – Before we issue the CAS, we require a deposit of 1/3 of your tuition fees for one year of studies (equal to one term's fees). Students accessing government/state student loans such as FAFSA, Lånkassen, CSN etc. must pay a £500 deposit.

To ensure the fee information included on your CAS document is correct, please confirm how much you have paid towards your tuition and accommodation fees (if you have booked private/non-AUB accommodation, you do not need to provide details).

Student Route Visa Applications – Financial Evidence

Before you can apply for your visa, you will need to show that you have sufficient money to pay your tuition fee PLUS a fixed amount of money for living expenses, known as 'Maintenance'.

Your deposit and any other sum of money already paid towards tuition fees will be deducted from the total amount of money you will need to show. These amounts will be clearly stated on your CAS and **should be checked carefully**.

Length of course	Maintenance (funds) needed	Example:
More than 9 months (1 academic year)	First year of course fees Plus at least £9,207 to cover living costs for 9 months in the UK (£1,023 per month)	If your tuition fee for your first year of study is £17,950 and you have paid a deposit of £5,984, then your remaining tuition fee to show will be £11,966. You would need to show £9,207 (living costs) + £11,966 = £21,173 in available funds.

Make sure that you have the right financial evidence for your visa

UK Visas and Immigration (UKVI) require evidence that you or your parents have held the correct amount of money continually for a consecutive period of 28 days.

Your evidence must demonstrate you have at least £9,207 for living costs plus all of the remaining tuition fees for the first year of your course. Your tuition fee and the amount already paid will be stated on the email containing your CAS.

The balance must not drop below the required amount for 28 days – not even 1 penny below that amount for a single day, or even part of a day. Please note, the 28-day period ends on the closing balance of your bank statement. The bank statements that you provide must be no more than 31 days old on the day you apply for your visa.

Use the official **exchange rate** website www.oanda.com to convert your currency to pounds sterling.

Funds will not be considered if they are held in a financial institution that won't allow UKVI to make satisfactory verification checks; that isn't regulated by the appropriate regulatory body for the country in which it is operating; or doesn't use electronic record keeping.

Check that your original bank statements showing the 28-day period include ALL of the following information:

Your name or your parent(s)/legal guardian(s) name - The account number - The date of the statement - The financial institutions name and logo - The amount of money available - The currency

If you are using your parents' or legal guardians' bank statements, then you must also provide:

Your original birth (or adoption) certificate showing the names of your parent(s)/legal guardian(s) **PLUS** a letter from your parent(s)/legal guardian(s) that confirms the relationship between you and your parent(s)/legal guardian(s) and that they have given their consent to you using their funds to study in the UK. *Please contact us if you want a template for a consent letter.*

Low risk nationals

Students from certain countries do not need to routinely provide evidence to show that they meet the financial requirements, however, these documents may be required by the decision maker as part of the visa application process, so it is important to be prepared. Before you submit your visa application you **MUST** carefully read the following documents:

The **UK Immigration Rules** are not flexible, and you **must** meet the required criteria in the above-mentioned documents, otherwise your visa application **will be refused**. If your visa is refused, we may not issue you with another CAS and any additional CAS we issue will incur an administration charge. **If your visa application is refused based on incorrect or invalid information or documentation provided by you, AUB will retain £1,500 of your deposit.**

Your visa application

Most students will need to apply for their Student Route visa from outside the UK and must wait for the decision before travelling to the UK. If you have a current, valid Student Route or Tier 4 visa that expires no more than 28 days before the start of your course, you may be eligible to apply from within the UK.

During the visa application process, you will be asked questions about your immigration history, your personal circumstances, and any criminal history and UKVI will check this information when assessing your application. If there is anything you are aware of that may have an impact on your visa application, including if you intend to bring a dependent, please declare it here:

Your data

The data you have provided on this form will be held on a secure server at AUB, in accordance with the UK General Data Protection Regulations, the Data Protection Act 2018 and AUB policies and any sharing of this data will be done using secure and audited systems.

The data will be used for the sole purpose of assessing your suitability for receiving a CAS, issuing your CAS, and communicating with UKVI about your visa application. Other than UKVI, we will not share it with any third parties.
