# Summary of 2024-25 to 2027-28 Access and Participation Plan

## What is an access and participation plan?

An access and participation plan (APP) sets out how universities ensure everyone, no matter their background, can gain places at and succeed at university as well as getting good employment (or further study) after they leave. Each university reviews and rewrites their APP every 4 years, to make sure they are up to date and able to tackle the current issues and barriers their students are facing.

# **Key points**

The focus of our APP is on improving the diversity of students from a range of different backgrounds who access the University to study, and on making sure that once they are here students from specific groups complete their studies, get a good degree outcome, and go on to successful, rewarding work once they graduate.

#### Our data shows that:

- > Students are less likely to **access** the University if they
  - o Are from Black, Asian or other ethnic minority backgrounds.
  - Are from geographic areas where there has been historically low participation in Higher Education.
  - o Are from a low-income background.
- > Students are less likely to **continue** with their studies at the University if they are care experienced or estranged from close family members.
- Students are less likely to attain first or upper-second class degree if they
  - Are care experienced.
  - o Are estranged from close family members.
  - o Are from Black, Asian or other ethnic minority backgrounds.
- > Students are less likely to **attain** with a first or upper-second class degree if they are from Black, Asian or other ethnic minority backgrounds.
- > Students are less likely to **progress** to professional or managerial employment if they are from a low-income background.

# **Risks to Equality of Opportunity**

To make sure we built a strong plan to tackle the gaps in our data for students from some groups, we carried out a university wide consultation with staff and students. This consultation allowed us to identify key risks to equality of opportunity which we think students from those groups might face at AUB. These risks are linked to:

- Gaps in GCSE attainment for young men who are eligible for Free School Meals
- Lower proportions of students studying at AUB from areas which are least socioeconomically advantaged.
- Lower proportions of students who live in neighbourhoods of low Higher Education participation at AUB.
- Lower proportions of students from ethnic minority backgrounds at AUB
- Gaps in continuation, completion and attainment for students who are care experienced and/or estranged.
- Barriers to progression into professional and managerial employment for students from a range of backgrounds who experience underrepresentation in the creative industries.

## What we are aiming to achieve

Our plan contains seven objectives and ten targets which aim to address the key risks to equality of opportunity. We believe that addressing these risks will reduce the gaps that exist between over and under-represented student groups at the University.

## What we are doing to address keys risks to equality of opportunity

To address our key risks, we have produced four intervention strategies. An intervention strategy is a group of activities or programmes that we will carry out to achieve the aims of our Access and Participation Plan. We have 4 intervention strategies in our plan, and each strategy consists of activities that will support our students who might be facing a risk at different stages of their student journey. Our intervention strategies are:

- 1. Increase the GCSE attainment of boys in Dorset who are eligible for free school meals.
- 2. Increase the number of applications and enrolments to the University for students who may have experienced socio-economic inequality, student from areas of historically low Higher Education participation, and students Black and Asian ethnic backgrounds.
- 3. Increase continuation and attainment for students at the University who are care experienced and/or estranged.
- 4. Increase graduate outcomes for students from backgrounds which a underrepresented within the University and the creative industries.
