

ATTENDEE WAIVER FORM

AUB 24 + RNLI / 24th – 26th February / RNLI Poole and AUB

(AUB24 + RNLI = the Event)

I, the undersigned, acknowledge and understand that it is a pre-requisite of my attendance and participation at the Event that I agree to the following:

1. The nature of the Event and my role in it has been explained to me and I have agreed to participate in, and collaborate on, the Event entirely of my own choice and free of charge.

Confidentiality

2. In relation to any information I come across during the Event relating to either the Royal National Lifeboat Institution (“RNLI”), the Event itself or any other information which might be regarded as (or is specifically notified to me as being) confidential information, I will treat this information as confidential, and will not discuss it with anyone outside the confines of the Event.

Intellectual Property

3. By signing up to take part in the Event, I agree to produce work for the RNLI and to not use anything created during the Event for personal commercial gain. I understand and acknowledge that all use of RNLI logos and assets must be used in accordance with RNLI brand guidelines and may be subject to approval from the RNLI.
4. I will assign to the RNLI, any and all rights, title, interest and property (including, without limitation, copyright) which I may have in any ideas, concepts, know-how, materials and other information which I either create during the course of the Event or which I supply during the Event for use at the Event or thereafter (“**Intellectual Property Rights**”).
5. I hereby waive all moral rights which I may have in all the Intellectual Property Rights and any rights I might otherwise have to recover and to bring proceedings to recover damages and/or to obtain other remedies in respect of infringement of the Intellectual Property Rights, whether committed before or after the date of my sign-up to the Event.
6. I shall, if requested by the RNLI, sign any documentation required by the RNLI to enable the RNLI to enjoy the full and exclusive benefit of the Intellectual Property Rights and to fully and effectively vest the Intellectual Property Rights in the RNLI.

Liability

7. I agree to indemnify the RNLI from any loss, liability, damage, or costs (including legal fees) that the RNLI may incur due to my participation in the Event, and/or as result of my failure to abide by the terms of this waiver form, unless any such loss, liability, damage or costs are incurred as a result of the negligence of the RNLI.

8. I acknowledge and understand that neither I nor the RNLI can exclude ourselves from any liability for death or personal injury caused by our own negligence, nor for wilful default, fraud or any other liability which cannot be excluded or limited by the laws of England and Wales.
